

Road Construction

Both the Kentucky House of Representatives and the Kentucky Senate have approved HB 330, which is the FYs 2009 and 2010 state road construction plan that outlines more than \$3.7 billion worth of road projects. HB 330 includes over \$440 million in projects funded by the American Recovery and Reinvestment Act of 2009, the federal economic stimulus legislation. These funds are slated to be spent before the end of the current fiscal year (June 30, 2009), and all money will be spent for construction.
