What is a Post COVID-19 Work Plan?

KLC is launching an initiative to help cities prepare for action in response and recovery in light of the coronavirus COVID-19 pandemic. We know that the crisis will have long-term effects on all aspects of our lives, including tax revenues and city functions.

The Kentucky League of Cities Community Development Services (KLC CDS) can help you take a look at where your city is and how it can move ahead post COVID-19. The sooner you start, the sooner your city will be prepared.

The CDS staff will help you create a work plan using front-end survey tools and remote means of communication. The result will be a customized action plan to address your city's specific concerns and issues coming out of this unprecedented health crisis and anticipated economic distress.

What's in it for you?

This intensive new model gives you, the leader of your city, a plan. As a result of this process, you will receive:

- A customized and targeted plan for your city to begin implementing now.
- Identified challenges and opportunities that your community will work on together.
- Clear goals, tactics and recommendations that allow you to implement immediately.

Who can participate?

Mayors are the initial audience for this initiative. You may wish to include council/commission members and/or department heads as the work unfolds. This consultation session will assist the team of leaders in identifying the best possible steps for your community to find success in today's reality.

How does it work?

You contact KLC CDS staff for a preliminary conversation to assess the known issues or challenges that your city will need to address. With that

information, a scope of work will emerge. In general, the process includes:

- You, as mayor, will fill out a preliminary worksheet to provide information to KLC CDS staff.
- KLC CDS will create a framework for further collaborative discussion of pertinent issues and concerns.
- A remote work session will be held to discuss and assess the situation, establish priorities and set goals.
- If further work sessions with your council/ commission or department heads are deemed necessary, a date will be set for additional discussions.
- KLC CDS will create a draft work plan in advance of a final work session.
- You will convene the last work session to collaboratively finalize content of the plan.
- KLC CDS will prepare a final work plan for the city to adopt and implement.

We are a small team, but we work efficiently. We will prioritize on a first-come, first-served basis. We will be forthright about when you can expect us to help you. We will not overcommit. We want every city that utilizes this service to receive our full attention, just as we have provided the past 10 years.

When and where?

KLC CDS is accepting calls now. If your city is concerned about remote access, we can utilize conference calls, emails, Microsoft Teams, Skype, FaceTime and other virtual platforms that are available to most cities and individuals. Just because the world pauses, doesn't mean that you must.
