

RENEWAL APPLICATION

- 1. Follow instructions for logging into the KLC Insurance Portal.
- 2. Once logged into the portal, you should see the section "Action Items For You," and in that section there will be a link for a Renewal Application that corresponds with each policy type you have with KLC. If your account has access to multiple member accounts, make sure you choose from the Underwriting Menu > Change Group to select the member for which you want to submit forms.
