



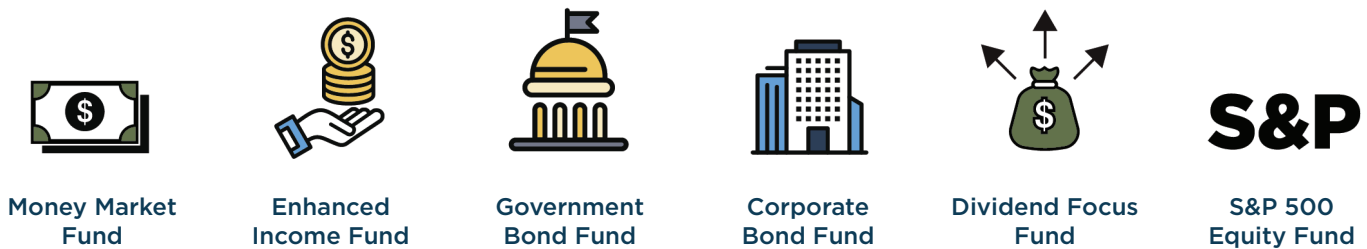

Program Overview

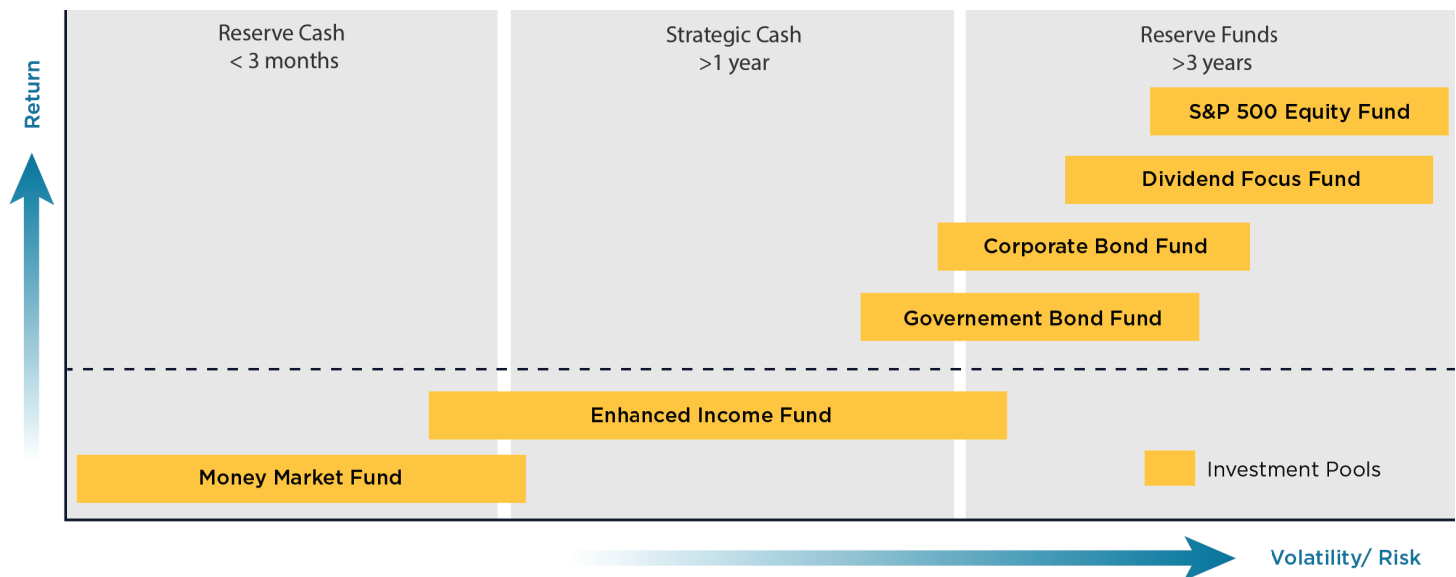

Investment Fund Summary



Money Market Fund

Investment seeks protection of principal while providing a competitive current yield by investing primarily in obligations issued or guaranteed by the U.S. Government, its agencies, or instrumentalities and repurchase agreements.

Stable Net Asset Value (NAV)



Enhanced Income Fund

Investment seeks to protect principal and provide a stable NAV by investing in Money Market Funds and U.S. Treasury securities purchased at a discount and held to maturity and providing a consistent income stream.



Government Bond Fund

Investment seeks a higher current yield than the Money Market Fund by investing in short- and intermediate-term U.S. Treasury Bonds. The portfolio targets a weighted average duration of less than four years with maturities ranging from between one to seven years.

NAV fluctuates daily based on market returns



Corporate Bond Fund

Investment seeks a higher level of current income and capital appreciation than the Government Bond Fund by investing in a diversified mix of corporate bonds with credit ratings of A or better and maturities of less than 10 years.

NAV fluctuates daily based on market returns



Dividend Focus Fund

Over time, this strategy is designed to participate in equity market advances but also to protect in market declines, while delivering an attractive dividend yield, growing income stream, and potential for positive earnings surprises.

S&P 500 Equity Fund

Investment seeks long-term capital appreciation by investing in the common stock of U. S. companies that are included in the S&P 500 Index. The key risk is the volatility that comes with its full exposure to the large cap stock market.

NAV fluctuates daily based on market returns

* The above items are in order according to their volatility, beginning with the least volatile.

- The program establishes a target asset allocation for each individual sub-account.
