

Total Claims LAW ENFORCEMENT WORKERS' COMPENSATION CLAIMS

05/01/24	Walking dog to the bathroom and bit R arm.
05/02/24	Mental health suspect spit requested water in IW face. Possible body fluid exposure to face.
05/02/24	L thumb bent backwards during arrest altercation.
05/02/24	Arrest altercation suspect bit R index finger breaking skin.
05/03/24	At traffic stop, driver slammed IW's arm in door driving off with shirt stuck in door about 75 ft. Injury to R arm/shoulder and pain to back.
05/03/24	Foot pursuit grazed by a vehicle. Pain to L wrist going to L arm and L knee.
05/06/24	MVA another vehicle ran red light. Airbags deployed. Burn to lower L abdomen and L forearm.
05/07/24	L lower arm pain abrasions to R arm from struggle with subject to ground.
05/08/24	Canine training and dog hit L knee causing it to buckle. L knee injury.
05/10/24	R hand pain after striking resisting subject.
05/11/24	Took suspect to ground hit L elbow on concrete causing abrasion and swelling.
05/13/24	Reinjured a previous injury to R knee, pain radiating from R knee to upper leg. Prior surgery in 2020 and 2022.
05/15/24	Eating breakfast dispatchers made. Took a bite from sausage patty. Chipped front tooth.
05/18/24	Vehicle pursuit and rear ended vehicle in pursuit. No physical injuries.
05/18/24	Police pursuit and sideswiped with another vehicle.
05/19/24	Jammed left thumb during altercation with a suspect.
05/19/24	Injury to right wrist while trying to arrest suspect.
05/21/24	Employee attempted to restrain prisoner in vehicle that kicked him multiple times during altercation injured R elbow.
05/22/24	Pain to arch of L foot while on a group run.
05/24/24	Trying to restrain subject that was slamming head against the cage bleeding on IW's arms, R leg, chest, and torso areas.
05/24/24	Arrest altercation sustained injury to palm.
05/25/24	Pop in bottom of R foot walking back to police cruiser.








