




Otal Claims	LAW ENFORCEMENT WORKERS COMPENSATION CEALING
10/4/2024	On an emergency call for a choking woman, placed hand inside closing door injuring L hand and wrist.
10/9/2024	Employee was bitten by a dog and the bite did not penetrate his bodysuit, but dog bit him on his rt forearm, which started causing numbness in his fingers.
10/10/2024	Foot pursuit with suspec,t fell to ground injuring L hand, R elbow, and both knees.
10/10/2024	Scraped L ring finger, L elbow, and both knees during a physical altercation with subject.
10/10/2024	Scraped R elbow during altercation taking juvenile to ground.
10/10/2024	Employee was fighting a suspect on the roadway. While doing so he received lacerations to his fingers on L hand and R knee.
10/11/2024	Arrest altercation, twisted R knee.
10/12/2024	Arrest altercation, injury to right knee.
10/13/2024	Employee was driving andlooking for a vehicle when he struck a concrete post, cutting the top of his head.
10/14/2024	R ring finger injury after carrying a resisting subject on stretcher.
10/16/2024	Arrest altercation, took suspect to ground causing L knee pain.
10/18/2024	Employee started to feel chest pain, flushed face, and became sweaty while driving.
10/23/2024	Sudden stop due to vehicle in front and was rear ended, causing headache and neck pain.
10/23/2024	Clearing homeless people from a building and was exposed to mold, animal and human feces, and urine. Inhalation of noxious fumes and gases.
10/23/2024	Clearing homeless people from a building and was exposed to mold, animal and human feces, and urine. Inhalation of noxious fumes and gases.
10/23/2024	Arrest altercation, struck multiple times in chest. L wrist twisted as it caught in cuffs, causing pain from middle of forearm down to fingers, with tingling sensation.
10/25/2024	Slipped off curb during recruit run, rolled L ankle.
10/25/2024	Car pursuit and then foot pursuit, tripped over the suspect and received multiple injuries.
10/25/2024	Trying to put handcuffs on a suspect, tripped over the officer on the ground, fell and injured R knee.
10/25/2024	Foot pursuit, struck R wrist and R shoulder while running.
10/26/2024	Foot pursuit, pain to L ankle.
10/28/2024	Felt dizzy, irregular heartbeat, high pulse rate. No physical injury.
